Introduction

Kosovo continues to face significant environmental challenges, which have a direct impact on the quality of life for its citizens. Air pollution remains one of the most serious issues, with the country continuing to experience alarming levels of pollution, primarily from coal-fired power plants and wood heating. PM2.5 and PM10¹ levels frequently exceed EU and WHO standards, harming public health, particularly the most vulnerable groups.² Kosovo leads the list of premature deaths due to high pollution levels, with approximately 2,370 deaths per million inhabitants.³

Kosovo, due to its geographical location and landlocked status, continues to be threatened by forest fires and floods. The World Bank has identified Kosovo as vulnerable to climate risks such as forest fires, floods, and landslides. Currently, 36.8% of Kosovo's total land area is at medium risk from fires, while 15.8% is at high risk.⁴

Another significant challenge for Kosovo is wastewater treatment. Construction of wastewater treatment plants is regarded as one of the most serious issues in the water industry. Also, Kosovo is far from European Union standards in terms of population access to wastewater treatment plants, with the average standing at 86% In Kosovo, the wastewater of only 8.15% of the population with access to public sewage managed by all RWCs is treated. This year, according to the Law on Budgetary Allocations for the budget of 2025, Kosovo aims to reach a percentage of 45%. This means that most of the wastewater in Kosovo is still discharged into the environment untreated, creating risks for public health and natural ecosystems.

On the other hand, the most recent European Commission report on Kosovo highlights that the country is still in the early stages of implementing the Green Agenda, particularly in the transportation, energy, and environment sectors. The report also highlights challenges in implementing waste management legislation, stating that Kosovo has made some progress with the adoption of implementing legislation on the export, import, transit and transboundary movement of waste, as well as with the adoption of legislation on package waste. These measures have laid the foundations for extended producer responsibility and application of the "polluter pays" principle. Progress has also been made in reducing the number of illegal landfills, from "747 in 2022 to 373 in 2023."

However, the country suffers from limited inspection capacities, while the Law on Waste Management and the Integrated Waste Management Strategy need to be amended to include recycling targets, as well as to adopt inter-municipal waste management plans.¹²

These challenges highlight the importance of a multi-sectoral approach, as well as rapid and well-coordinated actions at the central and local levels, in addressing environmental issues. In this regard, municipalities, as primary institutions of local self-government, have a key role in environmental protection, as they are responsible for important issues such as waste treatment, development of sustainable transportation infrastructure, development and protection of green spaces, development of infrastructure for the management of polluted waters, and risk management for protection from fires and floods. This paper analyzes the performance of 11 mayors in Kosovo with regard to fulfilling their green promises over the past three years since taking office. Having a clearer picture of the level of fulfillment of green promises by municipalities primarily aims at greater transparency and public accountability to citizens. It also improves understanding of how much these commitments have contributed and how well local green policies have been aligned with the objectives of the Green Agenda, an agreement reached by all governments in the Western Balkans region as an instrument of approximation with the European Union's Green Deal directive.

KDI measured the fulfillment of the green commitments of 11 mayors for the period 2021-2024, and the findings of this environmental scorecard resulted in specific recommendations for all stakeholders who have responsibility for the implementation of environmental policies and projects.

Executive summary

Mayoral candidates in Kosovo committed to a number of environmental projects during the 2021 local election campaign. However, an analysis of the programs by KDI and partner organizations of the Civic Alliance for Transparency (AQT) in 11 municipalities reveals that only a small portion of these commitments have been fulfilled. Specifically, by December 2024, only **27.27%** of green promises had been fulfilled, indicating a significant lack of accountability and an anemic approach to green governance.

Mayoral candidates' election programs, projects promoting environmental protection, and the expansion of green spaces had taken up a significant amount of space. Beyond the idea that green projects would be the focus of local government, they generally failed to establish themselves as well-analyzed projects, both in terms of technical implementation, time, the impact they would produce, or financial feasibility. Most of the green promises were more conceived as ideas and simple declarative formulations, such as "Maintenance and increase of green areas" (Bedri Hamza, Mitrovica), "Construction of bicycle paths" (Shpejtim Bulligi, Podujeva), "Construction of beau-



tiful parks and their maintenance" (Smajl Latifi, Rahovec), or "Opening and construction of new parks, including playgrounds for children" (Imri Ahmeti, Lipjan).

The lack of details on the manner and timelines of these projects' implementation, funding sources, community needs, environmental effects, exact locations or surfaces, maintenance and sustainability of the projects makes it difficult to understand whether these promises are built on the basis of feasibility or are simply part of the electoral campaign.

Analysis of election programs of 11 mayoral candidates revealed that out of the total of 1,816¹⁴ promises for 38 municipalities, in the 11 municipalities subjected to this analysis, only 154, or 8.48% of them are related to environmental protection as green projects in general.



Percentage of Green Promises within the Election Programs of the Mayors of Municipalities for the Mandate 2021-2025




The 154 green commitments examined in 11 municipalities are diverse in nature and cover a wide range of green governance issues. Some of the pledges centered on increasing green space, creating parks, and reforestation. For example, Pristina has promised to create 250 hectares of green space, whereas Rahovec intends to afforest 17 hectares. Municipalities in Kaçanik, Gjakova, and Kamenica have also pledged to create green spaces.

Alternative transport was another promise, with projects such as construction of bicycle and walking paths in Pristina, Peja, Rahovec, Mitrovica, Podujevo, Kamenica and Skenderaj. Prishtina has also aimed to develop environmentally friendly public transport, including expanding the electric bus network. Meanwhile, Podujeva, Skenderaj and Kamenica have invested in the construction of new bus stations.

Another area with a lot of promise was increasing energy efficiency through energy-saving facades on public and private buildings, as well as installing solar panels on public buildings in Rahovec, Pristina, and Kaçanik.

Despite the diversity of promises, the analysis reveals that a significant portion of projects are still in the early stages of implementation or are primarily concerned with the creation of parks and green spaces. Meanwhile, more complex initiatives, such as implementing energy efficiency programs and creating sustainable waste management systems, continue to face significant challenges in implementation.

How much space did green management occupy within the electoral platform in the municipalities?



With regard to the ambitious commitments that Kosovo has made under the Green Agenda and Implementation Plan, the election promises and political offers of mayoral candidates in 2021 were generally not coordinated with these commitments.

Given that these election programs were voted on by citizens, the question is, were these promises kept? More importantly, how do they affect the real lives of citizens?

According to the analysis of KDI and partner organizations part of the Civic Alliance for Transparency (AQT) in 11 municipalities, the fact that only **27.27%** of green promises have been fulfilled, while the municipalities are already in their final year of government, indicates a significant lack of accountability in the implementation of green promises.

Methodology

The Kosovo Democratic Institute (KDI), in collaboration with 11 local non-governmental organizations that are members of the informal coalition "Civic Alliance for Transparency," has monitored and evaluated the fulfillment of the green promises made by 11 mayors of municipalities, which were disclosed to citizens in the form of written election programs during the 2021 local mayor elections. Monitoring and evaluating municipal performance aim to increase transparency and institutional accountability for implementing green policies or projects.


The monitoring of electoral promises was done during 2024 and is based on public information from 2021-2024. The monitoring was completed on 31st of December 2024, and its findings reflect the situation up to that date. To assess municipalities' performance in terms of green governance, public data and documents (annual budgets of municipalities, Medium-Term Budget Frameworks, public contracts, work reports, etc.) were collected and analyzed. Information was also obtained through formal communications with representatives of municipal institutions and through verification of the status of project implementation on the ground, through visits.

The municipalities that are part of this assessment are Prishtina, Mitrovica South, Lipjan, Ferizaj, Gjakova, Kaçanik, Rahovec, Skenderaj, Podujevo, Kamenica and Peja. The results of the assessment of the implementation of promises, i.e. municipal green projects, are categorized into 4 levels: not started, started, semi-completed and completed.

Monitoring in each municipality was carried out in cooperation with local partner organizations: "Mundësia" in Mitrovica, "POLIS" in Lipjan, "AvoNet" in Ferizaj, "Qeliza" in Gjakova, "Gjethi" in Kaçanik, "Center for Policy and Advocacy" (QPA) in Prishtina, NGO "SHL Kosova" in Rahovec, "Skenderaj Civic Initiative" (IQS) in Skenderaj, "Ekovizioni" in Podujeva, NGO "Fortesa" in Kamenica and "Syri i Vizionit" in Peja. These organizations contributed to the collection nd verification of information.

Through this assessment, KDI hopes to strengthen local governance and raise awareness about the importance of implementing sustainable environmental policies in Kosovo. The assessment identifies best practices and encourages improvements in the implementation of green policies.

MUNICIPALITIES' PERFORMANCE IN FULFILLING GREEN PROMISES

Municipality of Pristina

A significant step toward making Prishtina a more sustainable and eco-friendlier city is represented by the green promises made in Mayor Përparim Rama's 2021 election platform. These include measures to enhance air quality, manage wastewater and waste sustainably, control alternative modes of transportation, increase green space, and use efficient energy. This program is generally assessed to be in line with the competencies and responsibilities of local government institutions, as most of the promises, including building facades, waste management, expanding green spaces, wastewater management, public transport, etc., are within the direct competence of municipalities. However, the challenge ahead remains whether the remaining projects will be able to be finalized within the governing mandate as promised during the electoral campaign.

In the Municipality of Prishtina, the current mayor, Përparim Rama, had a written election program, but it is not accessible online. Out of 206 total promises made during the campaign, 43 focused on environmental issues, which accounts for 20.9% of the total promises. The election program includes green promises, but there are no precise or approximate budget estimates for these projects in the election program. In terms of deadlines, the election program also does not set precise deadlines for the implementation of green projects (such as specific time periods).


The level of fulfillment of the mayor's promises varies by area, reflecting some projects that have begun and a limited number of those that have been fully completed, as well as some projects that have yet to be implemented. Although some of them have been included in the 2025 budget, there are still projects that have not begun and no information on when they will be completed.

Municipality of South Mitrovica

The electoral program of the Municipality of Mitrovica, under the leadership of Mayor Bedri Hamza, has presented several green promises aimed at improving environmental conditions and developing public spaces, mainly through investments in river infrastructure, waste management and increasing greenery. From a green perspective, these goals are extremely important for citizens and preserving biodiversity, providing a positive starting point for sustainable local development. However, the analysis shows that not all promises fully align with local level competencies - such as cleaning up industrial waste, which consequently create expectations that the municipality may not fully meet. On the other hand, while only a small number of promised projects have been successfully completed or have reached an advanced stage, most of the promises still remain in the initial phase.

In the Municipality of South Mitrovica, the mayor had a written election program during the 2021 local elections, but it is not accessible online. Out of a total of 123 electoral promises made during the campaign, 10 promises are focused on environmental issues, accounting for 8.13% of the total promises. The election program does not include precise budget calculations for green projects. The exact budget dedicated during this mandate for green projects is not known since municipal institutions have not responded to the request for access to this information on this issue, but from the information obtained from the municipality's website, it is deduced that 246,011.70 euros have been dedicated for 2024. The mayor's election program does not set precise deadlines for the implementation of green projects. Also, the existing human capacity of the municipality was not considered when proposing these projects within the program.


From the analysis of the implementation of green promises, it is clear that most projects have only just begun, while a small part has progressed or been finalized. This situation highlights the need for a higher commitment from municipal structures towards fulfilling the promised projects so that the commitments to apply green practices are concretized in practice.

Municipality of Ferizaj

The projects presented in Agim Aliu's electoral program for the Municipality of Ferizaj represent initiatives for improving the environment in this municipality. Interventions such as cleaning and regulating riverbeds, expanding parks and increasing waste management capacities are necessary for a city that is facing rapid urbanization and challenges related to urban congestion. The monitoring shows that most of the promises have been fulfilled, but it is important that the remaining initiatives are accompanied by other concrete steps in relation to the creation of green spaces, more advanced solutions for pollution management and sustainable development of urban infrastructure.

The Mayor of Ferizaj has published a written election program, which is accessible online. Of the 69 promises made during the campaign, 9 of them focused on environmental issues, which accounts for 13% of the total promises. The program includes green promises, but does not provide exact or approximate budget estimates for these projects specified in the platform. However, the total value of investments in environmental projects is €7,050,000.00, according to data received from the Municipality. Regarding the deadlines, the Municipality has emphasized that the projects are part of the governing platform and will be completed by the end of the mandate, but that there are no such time limits in the election program.

Regarding the level of implementation of green promises in Ferizaj, it appears that most of them have been fulfilled, including the continuation of the construction of wastewater collectors, the greening of intersections on city streets, the creation of bicycle parking lots, the expansion of recreational spaces and the improvement of waste management capacities. However, some projects, such as the regulation of river beds and lobbying to attract investors, remain still in progress or in the initial phase, for which further commitment is needed.



Municipality of Peja

The electoral program of the Municipality of Peja, under the leadership of Mayor Gazmend Muhaxheri, has included a series of promises for the development of infrastructure, with a focus on improving mountain tourism, managing water resources and wastewater, and creating green recreational spaces. The initiatives presented are within the municipal competences, including investments in the road network, water and environmental infrastructure, with some progress already visible. The analysis of progress shows that some of these projects need a faster pace of implementation and a greater commitment in order to achieve concrete and tangible results for the community.


In the Municipality of Peja, the current mayor did not have a written election program. During the electoral campaign, the mayor made 25 promises, of which 10 focused on environmental issues, which accounts for 40% of the total election promises. Regarding the budget estimates, the municipality announced that funds dedicated to green projects have been allocated, with the budget allocated as follows: 120,000 euros in 2022, 230,000 euros in 2023, 100,000 euros in 2024 and 160,000 euros in 2025.

Municipality of Rahovec

The electoral program presented by Smajl Latifi for the Municipality of Rahovec includes promises in the fields of agriculture, green energy, water infrastructure, environmental protection and the creation of recreational spaces. The main initiatives include the expansion of the irrigation system, wastewater treatment, cleaning of illegal landfills, the construction of trails and parks, as well as investments in renewable energy. Overall, the majority of projects have made progress towards implementation, while a small number still remain in the initial stages.

Regarding the election program for the Municipality of Rahovec, the mayor had a written one, but it is not available online. Out of 84 promises made during the campaign, 22 focused on environmental issues, which accounts for 26.19% of the total promises. The green promises do not have precise or approximate budget estimates specified in the election program. In terms of deadlines, the program did not set precise deadlines for the implementation of green projects. Also, this program did not consider the existing human capacity of the municipality to implement these projects.



Municipality of Gjakova

The electoral program of the Municipality of Gjakova, presented by Mayor Ardian Gjini, is based on a series of promises that include interventions for environmental protection and management, namely the construction of irrigation canals, wastewater treatment, river regulation and the implementation of efficient technology such as LED public lighting. During the assessment of the implementation of this program, it is noted that, although some projects have been successfully implemented, others are still in progress or face delays, highlighting the need for further engagement and more practical monitoring. This electoral program, although not published online, contains a total of 35 promises made during the campaign, of which 9 are focused on environmental issues, which constitute 25.7% of the total promises. In the electoral program, green projects do not have defined financial values and an exact value for all green investments is not known, as the Municipality of Gjakova has not provided complete information on the total expenses incurred so far in this regard. Regarding the timelines, the program mentions deadlines for the implementation of projects, but not for all initiatives. Meanwhile, the program also does not provide a detailed analysis of the municipality's existing human capacities for the implementation of green projects.





Municipality of Lipjan

The electoral program of the Municipality of Lipjan includes promises focused on improving the environment, managing natural resources and developing public spaces. These projects, such as opening and maintaining rivers, building parks, regulating river beds and planting ornamental trees, address tangible needs for the community, contributing to improving the quality of life, reducing floods and creating recreational spaces for citizens. All of these projects are in line with the competencies of the local level.

In the Municipality of Lipjan, the mayor had a written election program during the 2021 local elections, but it is not accessible online. Out of a total of 61 electoral promises made during the campaign, 9 are focused on environmental issues, accounting for 14.75% of the total promises. The election program does not include precise budget estimates for green projects. However, based on the data available in the annual municipal budgets, the value of funds dedicated to the implementation of green projects so far amounts to €4,423,102.90. Meanwhile, the total budget for green projects for this mandate is €5,499,076.30, which includes both completed projects and those currently in the implementation process and expected to be completed during 2025. The mayor's election program does not set precise deadlines for the implementation of green projects.





Municipality of Skenderaj

The electoral program of the Municipality of Skenderaj, led by Fadil Nura, includes a series of promises focused on the development of environmental infrastructure, improving public services and protecting the environment. The main initiatives include expanding the sewage network, building walking trails, improving the supply of drinking water and improving public transport. These promises fall within the municipal competences and have marked significant progress. Overall, most of the projects have been completed or are in advanced stages of implementation, while some initiatives still remain in the preparatory process.

Out of a total of 66 electoral promises made during the campaign, 8 are focused on environmental issues, accounting for 12.12% of the total promises. The mayor's election program does not set precise deadlines for the implementation of green projects, and regarding the budget dedicated to green projects during the governing mandate, the Municipality of Skenderaj has not provided information.



The electoral program of the Municipality of Podujeva, under the leadership of Mayor Shpejtim Bulliqi, includes promises oriented towards the development of agriculture, management of natural resources and improvement of urban infrastructure (urban mobility). The main initiatives include the construction of bicycle paths, the expansion of the drinking water supply network and the irrigation system for agricultural lands, as well as the planting of trees and the afforestation of green areas. All these promises are within the competence of local government.



Municipality of Kamenica

The electoral program of the Municipality of Kamenica, presented by Mayor Kadri Rahimaj, focuses on several green promises aimed at improving environmental conditions, waste management, alternative transport and wastewater management. Most of these initiatives fall within the competence of local government. The exception is the athletics stadium project, which is financed and managed mainly by the Ministry of Culture, Youth and Sports (MCYS), which bears the main responsibility for its implementation. When assessing the progress of these promises, it is noted that some projects have reached important stages of implementation, while others have not yet started or are facing delays.

In the Municipality of Kamenica, the current mayor had a written election program, but it is not accessible online. Out of 56 promises made during the campaign, only 7 were focused on environmental issues, i.e., 12.5%. There was no precise budget calculation for these projects, but based on the contracts implemented and those in process, the total value of green investments amounts to 4,384,986 euros. Despite these investments, no precise deadlines have been set for the implementation of the projects, and the existing human capacity of the municipality for their implementation has not been considered within the framework of the program.





Municipality of Kaçanik

The electoral program of the Municipality of Kaçanik, presented by the Mayor Besim Ilazi, has included promises for investments in irrigation of agricultural lands, expansion of water supply networks in urban and rural areas, construction of sewage collectors, improvement of stream beds and waste management, as well as increasing energy efficiency. It is worth noting that, although the Municipality of Kaçanik has launched several projects and fully implemented some, a very large number of promised initiatives have not yet received the necessary impetus.


In the Municipality of Kaçanik, the mayor had a written election program, but it is not accessible online. Out of a total of 94 electoral promises made during the campaign, 28 focused on environmental issues, which accounts for 30% of the total promises. The election program includes green promises without budget estimates for these projects. However, based on calculations from budgeted projects over the years, the total amount of investments dedicated to green projects promised during the campaign is 1,298,550.89 euros. Not all of these funds have been spent, as many projects are still in the initial stages or in the implementation process, as can be seen in the analysis below. The Green Agenda for the Western Balkans and the **Local Reality**

The Green Agenda for the Western Balkans, also known as the Sofia Declaration¹⁵ is an important initiative that aims to align the region's policies with the objectives of the European Green Deal¹⁶ which serves as the European Union's (EU) new growth strategy towards building "a modern, climate-neutral, resource-efficient and competitive economy." This agenda aims to promote sustainable development through five main pillars: 1) decarbonization, 2) circular economy, 3) elimination of pollution, 4) sustainable agriculture, and 5) protection of nature and biodiversity. 18

According to the Regional Cooperation Council (RCC) report on the implementation of the Green Agenda Action Plan for the Western Balkans, Kosovo has made some initial steps in this process, especially in terms of the legal framework.¹⁹ Specifically, the Law on Climate Change²⁰ and the Energy Strategy 2022-2031 have been drafted and adopted²¹ which constitute important steps towards alignment with the objectives of the Green Agenda. The KDI report for 2023 also highlights progress in this regard, including the Law on the Promotion of Renewable Energy Sources, but emphasizes that Kosovo is still in the initial phase of fulfilling the obligations of this agenda.²²

The Action Plan for the Implementation of the Green Agenda also emphasizes that the Western Balkans, through municipalities, has a great potential to promote "green development" 23 and to increase environmental awareness among citizens, given that municipalities, within their own competences, address important segments intertwined within the five pillars of the Green Agenda. Specifically, the competences of municipalities in Kosovo, such as waste management, wastewater treatment, eco-friendly local transport, digitalization and the development of smart cities²⁴ are in line with the objectives of the Green Agenda. In addition, other areas such as local heating and energy

efficiency, maintenance of green spaces and biodiversity, sustainable tourism and ecological agriculture are also part of the measures that can and should be implemented at the municipal level. However, "Kosovo municipalities are not included in any structured mechanism at the state level to coordinate on the obligations arising from the Green Agenda and that fall under their responsibility." ²⁵

The Municipality of Prishtina has taken several steps in developing infrastructure for smart cities, while the Ministry of Economy and the Municipality of Gjilan have signed an agreement for the project "Piloting the Smart City Concept (Neutral Host)." The "Smart City Kosova" project is another project that aims to collaborate between five universities from different countries to develop a National Strategy for Smart and Sustainable Urban Development. This project also includes the creation of specific smart city strategies for seven cities in Kosovo: Prishtina, Prizren, Ferizaj, Peja, Gjilan, Vushtrri and Lipjan.²⁶

Central and local institutions often fail to fulfil their public commitments, including those related to environmental projects and initiatives. In the period 2021-2024, the fulfilment of electoral promises for 38 municipalities reached only 42.13%²⁷ (update June 2024), while according to the analysis of KDI and partner organizations part of the Civic Alliance for Transparency - CAT in 11 municipalities that are the subject of this analysis, the fact that only 27.27% is the full fulfilment of green promises from 2021 until the end of the last year of this mandate (December 2024) indicates an extremely low level of implementation. Consequently, over 70% of the promises have either been partially fulfilled or have not started. This situation shows the urgent need to strengthen the more responsible approach of municipalities towards their promises, and in particular green promises that should contribute to more sustainable and responsible policies in the implementation of the Green Agenda.

The promotion of green projects, although seen as a necessary and attractive strategy by mayoral candidates and political parties during the election campaign, has not been materialized to the appropriate extent in local government practice. The insufficient level of knowledge in the field, especially regarding the obligations that Kosovo and its institutions had assumed by signing the Green Agenda, and the complexity of implementing these projects due to the lack of proper analysis, human and financial capacities have caused municipalities to lag behind in their implementation.

Despite Kosovo's commitments to align national policies and projects with the EU Green Deal, the Western Balkans Green Agenda Agreement and Action Plan, their implementation has been weak and slow, often due to the lack of a multi-sectoral, inter-institutional approach and structured coordination between central and local level institutions. Also, "there is a significant lack of institutional capacities to effectively implement these commitments, for which the government, in regional meetings, has requested assistance to increase and strengthen institutional capacities in the implementation of this Agenda."²⁸

A clearer structure of cooperation between the central and local levels would help in a more efficient implementation of sustainability policies, ensuring that municipalities have the necessary support and resources to meet the objectives of the Green Agenda.

How Informed Are Municipalities About the Green Agenda?

The fulfilment of green electoral promises is closely tied to broader commitments to the green transition and sustainable development. Many of the pledges made by mayors during the 2021 municipal election campaign should not be seen solely as local projects, but rather as part of the country's wider objectives to contribute to the green transition of Kosovo and the region. Achieving this requires deep reforms in sectors such as energy, circular economy, pollution control, biodiversity, and sustainable agriculture.

In Kosovo, although the central government holds the primary responsibility for developing green policies and reforms, the Green Agenda Action Plan clearly assigns a significant share of the implementation duties to municipalities. Local authorities play a crucial role in translating green commitments into concrete actions—through projects aimed at reducing pollution, improving public transport, managing waste, preserving biodiversity, enhancing air quality, and more.

An analysis of the implementation of green promises by municipalities revealed a key issue: a lack of awareness among local authorities about the Green Agenda and their obligations under it. To better understand the underlying reasons, KDI conducted a survey with 11 municipalities. The aim was to gather insights into the level of awareness, involvement, capacity, and challenges that local authorities face in this process. Municipalities were asked whether they are familiar with the Green Agenda's key documents, how they received the information, whether they coordinate with others, whether clear communication channels exist with central institutions or among themselves, and if they have participated in informative meetings or workshops related to the Agenda.

According to the findings, all municipal officials surveyed reported that they had heard of the Green Agenda for the Western Balkans. Key sources of information include social media, official EU documents, trainings provided by NGOs and donors, as well as traditional media. Of those surveyed, 73% said they had read the main Green Agenda document, while 27% had not consulted it yet. Regarding the Action Plan, 82% stated they were informed, whereas 18% were not. These findings indicate a relatively good level of awareness, but also point to the need for improved access to more detailed information and supporting materials. This highlights the importance of more structured initiatives to deepen understanding and enhance effective implementation of green commitments at the local level.

When asked about their participation in meetings related to the Green Agenda or its implementation, 82% of officials said they had attended at least one meeting, workshop, or public discussion in the past three years. These events were mostly organized by NGOs, donors, and central public institutions. On the other hand, only 55% of officials reported being aware of any inter-institutional coordination mechanism, with most responses reflecting a lack of clarity or full understanding of such mechanisms.

While municipalities are actively implementing a variety of projects that contribute directly to the goals of the Green Agenda, the financial backing for these projects remains heavily reliant on donors. Some projects receive support from municipal budgets, the central government, or dedicated funds such as the Kosovo Energy Efficiency Fund.

One of the main challenges identified is the absence of a regular mechanism for reporting progress on green projects. Even though these projects are part of the Green Agenda Action Plan, it remains unclear whether municipalities are reporting in a structured manner to the central government. This creates gaps in monitoring and evaluation. Only 27% of officials stated that their municipality has a formal reporting practice, and even then, the reporting is typically directed toward the institutions funding the projects rather than to the central government. Meanwhile, 64% are unsure whether such a mechanism exists, and 9% confirmed that their municipality does not have one. This lack of clarity makes it difficult to form a national picture of the Green Agenda's progress and hinders the ability to compare results and challenges between municipalities.

In summary, the high level of municipal involvement (82% participation in Agenda-related meetings and 100% in green project implementation) indicates strong engagement in environmental sustainability. However, the fact that some municipalities are implementing green projects without realizing their connection to the Green Agenda underscores the need for better coordination and awareness of the strategic framework and long-term goals. Moreover, the finding that 27% of officials have not read the core Agenda document, and 45% are unaware of coordination mechanisms, reflects the need for more effective communication and a structured approach to information sharing. With only 27% of municipalities following a regular reporting practice, and the majority either uncertain or lacking such mechanisms entirely, there is a clear need for a unified reporting framework to improve progress tracking and accountability.

RECOMMENDATIONS

For the Mayors of Municipalities:

- Mayors must provide human and financial resources to implement the green projects promised during the campaign.
- Environmental projects should be based on municipal development plans, budget projections, local self-government legislation and be harmonized with national environmental policies, including long-term objectives and the action plan produced by the regional agreement on the Green Agenda.
- Municipalities should establish periodic reporting mechanisms for citizens on the progress of promised projects, including progress and challenges.
- Municipalities should plan budgets and resources for the long-term maintenance of green projects, ensuring their sustainability.
- Mayors and municipalities themselves should intensify regional cooperation on issues arising from their obligations for waste management, wastewater management or water resources.
- The exchange of good practices between municipalities that have been successful in green projects should be encouraged.
- Municipalities should build environmental education policies and implement policies that sanction environmental polluters.
- Providing tax breaks or incentives for enterprises that apply environmentally friendly practices, such as renewable energy or sustainable waste management.
- Support for farmers who apply ecological agricultural practices, such as agroforestry or the use of water-saving techniques.
- Municipalities should establish community recycling centres.

For central institutions:

- The government should establish a communication, monitoring and reporting mechanism with municipalities to ensure the integration and implementation of the Green Agenda at all levels of governance.
- The government should increase the engagement of relevant stakeholders in the design and implementation of environmental policies in accordance with the obligations undertaken as a state within the framework of the Green Agenda for the Western Balkans.

- The government should turn the environmental tax into environmental investments.
- The government, in cooperation with municipalities, should promote the treatment of recyclable waste and invest in the necessary infrastructure for its treatment.
- The government should promote sustainable transportation through subsidies for ecological interurban public transportation.

For citizens:

- Citizens should monitor and hold mayors accountable for their environmental promises.
- Citizens should engage in public consultations, budget hearings, and citizen initiatives to influence policies that affect the environment and their quality of life.
- Citizens should report environmental degradation through various forms, including using the kdi-green. org platform.
- Citizens can contribute by participating in voluntary organizations to contribute to environmental protection.

For political entities:

- The election programs of candidates for mayors and political entities, with an emphasis on projects related to green governance, must be well-specified, measurable, and provide details on the technical implementation plan, feasibility and financial cost, timelines, locations, the effect that these projects will produce, and above all, demonstrate their basis in community needs.
- Electoral promises should be based on local self-government competencies to guarantee enforceability and accountability.
- The election programs of candidates for mayors and political entities must reflect the objectives of the Green Agenda, namely the obligations that Kosovo has undertaken within the framework of this agreement, with special emphasis on those that fall under the responsibility of municipalities.
- Political entities and mayoral candidates should work with citizens to inform them about the details of election programs, to strengthen transparency and accountability.
